I, for myself and on behalf of my child(ren) and/or legal ward, heirs, administrators, personal representatives, or assigns, do agree to hold harmless, release and discharge Tampa VR Center of and from all claims, demands, causes of action, and legal liability, whether the same be known or unknown, anticipated or unanticipated, due to Tampa VR Centers ordinary negligence: and I, for myself and on behalf of my child(ren) and/or legal ward, heirs, administrators, personal representatives, or any assigns, further agree that except in the event of Tampa VR Centers gross negligence and willful and wanton misconduct, I shall not bring any claims, demands, legal actions and causes of action, against Tampa VR Center for any economic and non-economic losses due to bodily injury, death, property damage sustained by me and/or my minor child(ren) that are in any way associated with Tampa VR Center.

I further grant Tampa VR Center the right, without reservation or limitation, to photograph, videotape, and/or record me and/or my child(ren), by any

available means and to use my or my child(ren)'s first name, face, likeness, voice and appearance in connection with exhibitions, publicity, advertising, promotional materials, and security purposes.

I further acknowledge the fact that Tampa VR Center reserves the right to refuse service to anyone for any reason at any time. If any portion of this release from liability shall be deemed by a court of competent jurisdiction to be invalid, then the remainder of this release from liability shall remain in full force and effect, and the invalid provision will be removed.
